Seafarms Group Limited subsidiary, CO2 Australia Limited, secures further Commonwealth government contracts under the Direct Action Plans 20 Million Trees Programme

Seafarms Group Limited (**ASX: SFG**) is pleased to advise that its environmental services subsidiary, CO2 Australia Limited (**CO2 Australia**), has secured new contracts with the Commonwealth government under the Commonwealth's 20 Million Trees Programme (**Programme**).

CO2 Australia was first appointed as a large-scale provider to the Programme in April 2015, when it secured contracts to deliver five significant revegetation projects designed to protect and restore the environment and make agriculture more sustainable and productive.

Today, Minister for the Environment, the Honourable Greg Hunt, announced CO2 Australia as successfully securing contracts in relation to an additional two projects under the Programme.

These newly contracted projects, which are located in Queensland, focus on establishing vegetation habitat for the critically endangered Regent Honeyeater and re-establishment of threatened rainforest vegetation communities. On-ground delivery will occur progressively from 2016 to 2018 and involve a diverse range of stakeholders, including National Parks agencies, land-care organisations and local landholders.

Under today's announcement from the Minister, a total of \$8 million (GST inclusive) was awarded across contracts with the three successful large-scale providers, including CO2 Australia. In total, 10 projects will be delivered by the three providers amounting to 2.5 million trees to be delivered through this latest round of contracts.

Progress by CO2 Australia on the five projects awarded under previous 20 Million Trees contracts is ahead of schedule, with site preparation nearing completion and the majority of the planting expected to occur across this coming winter.
